Intimation regarding the corporate insolvency resolution process initiated with respect to company M/s Bodhtree Consulting Limited and interim order dated 11.05.2022 by Hon'ble NCLT, Hyderabad Bench-2, Hyderabad passed in CP(IB)No.144/7/HDB/2021

Dear Sir/Madam.

- 1. A company namely Equivas Capital Private Limited has filed a company petition(CP(IB)No.144/7/HDB/2021) under section 7 of the Insolvency and Bankruptcy Code, 2016 against our Company M/s Bodhtree Consulting Limited based on alleged claim of Rs.1.51 crores before NCLT, Hyderabad Bench-2, Hyderabad. Bodhtree Consulting Limited has filed its counter denying the liability. Equivas Capital Private Limited has filed its rejoinder stating that amounts are payable.
- The above stated company petition came up for hearing on 04.05.2022. The NCLT after hearing both the parties has admitted the company petition into corporate insolvency resolution process and passed docket order stating that detailed order would follow.
- 3. As the matter stood thus, in the interest of all the stakeholders, the company has drawn two demand drafts i.e., DD No.370138 dated 07.05.2022, HDFC Bank for Rs.75,79,747/- and DD No.370139 dated 07.05.2022, HDFC Bank for Rs.76,00,000/- requesting Equivas Capital Private Limited for settlement of the issues and an email was addressed to them on 08.05.2022.
- 4. As Equivas Capital Private Limited was not responding, the Company has filed an interlocutory application i.e., IA No.455/2022 praying the Hon'ble NCLT to stay all the further proceedings in view of the demand drafts drawn for settlement or to direct Equivas Capital limited and Resolution Professional to withdraw the company petition.
- 5. The NCLT after hearing both parties on 11.05.2022, have passed an interim order directing Equivas Capital Private Limited not to proceed with appointment of Resolution Professional and with corporate insolvency resolution process till next date of hearing and posted the interim application for hearing on 30.05.2022.

We request you take note of the developments and we shall keep you updated regarding the proceedings.

ORDER

Learned Counsel for the Financial Creditor appeared via video conference and Learned Counsel for the Corporate Debtor appeared in person.

This Petition has been filed by M/s. Equivas Capital Pvt Ltd against M/s. Bodhtree Consulting Ltd. as the Corporate Debtor had defaulted to pay an amount of Rs. 1,51,79,747/-. The Financial Creditor annexed various documents as contained in the index along with the Petition. The Index is to be reproduced. Learned Counsel for the Financial Creditor draws our attention on Page No.12 wherein the Corporate Debtor had categorically admitted the fact that an amount of Rs. 1,37,05,474/- is outstanding as per the Ledger account copy annexed, which has been given as inter-corporate deposit by the Financial Creditor to the Corporate Debtor. The Financial Creditor has also drawn our attention on Page No.15 wherein the demand was raised by the Learned Counsel for the Financial Creditor.

In view of the sufficient proof produced, there is no necessity to look in to any counter as papers that are filed in support of the Application clearly prove the case of the Financial Creditor.

Hence, the Petition is admitted. Order in usual format will follow.
